PARTICIPANT'S WAIVER OF LIABILITY

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING IT, YOU ARE GIVING UP LEGAL RIGHTS.

For entry to Katapult premises and participation in activities conducted by and at Katapult:

ASSUMPTION OF RISK: I certify that I am in good physical health, and do not have any medical condition that may preclude me from safely participating in the activities offered by Katapult including, but not limited to, the use of trampolines and inflatables. I am aware that using said equipment and Katapult's other facilities has inherent risks, including serious physical injury and death. I further understand that no person has permission to use the Katapult facility without an effective and validly signed Waiver of Liability, and that a Waiver is only valid if signed by an adult or guardian of at least eighteen years of age. Under the terms of this Waiver, I will assume all of the risk and responsibility for any injury, death or disability that may result from my voluntary participation, or from that of any wards listed under my name.

RELEASE OF LIABILITY: I agree that it is my voluntary and informed decision to release any liability, lawsuits or claims that I, my successors, or my heirs may have on behalf of myself, or my wards, against Katapult and its affiliates, instructors, officers, directors, agents, employees, designers, licensors, and members, as well as the property owner and tenants of the property and owners, manufacturers and installers of the equipment comprising the Katapult facility (collectively, the "Releasees").

This release is valid and effective whether the damage, loss, injury or death is a result of any act or omission on the part of any Releasees, or from any other cause, including, but not limited to, (a) use or misuse of the facility in any way by anyone, (b) use of any malfunctioning equipment, (c) improper maintenance of the facility, grounds, or any equipment, (d) instruction or supervision, or (e) slipping, tripping, and/or falling while in the facility or in the surrounding premises.

Any lawsuit arising from the use of the Katapult facility shall be brought in a court in Singapore, and Singapore law shall apply to any dispute. I hereby waive my right to trial and agree that any controversy between included parties will be resolved through the mediation process.

I further grant Katapult the right to photograph, videotape, and/or record me and to use my name, face, likeness, voice and appearance in connection with exhibitions, publicity, advertising, and promotional materials without reservation or limitation. I grant permission to contact me via my email address with special offers, events and promotions.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS WAIVER AND FULLY UNDERSTAND THAT IT IS A WAIVER OF ANY RIGHT THAT I MAY HAVE ON BEHALF OF MYSELF OR MY WARDS TO ASSERT A LEGAL CLAIM FOR DEATH, INJURY OR LOSS OF ANY KIND AGAINST KATAPULT. SHOULD ANY CLAIM BE MADE, I UNDERSTAND AND AGREE THAT I WILL BE RESPONSIBLE FOR, AND WILL REIMBURSE THE RELEASEES, ALL ATTORNEY'S FEES AND DEFENSE COSTS INCURRED BY THE RELEASEES IN CONNECTION WITH OR IN DEFENSE OF THAT CLAIM.
